Within the scope of the strategic cooperation agreement signed between Borsa İstanbul A.Ş. and NASDAQ on January 20, 2014 about the renewal of the Borsa Istanbul markets operations and technological infrastructure, Futures and Options Market will be migrated on the BISTECH platform in the second phase of the project.

Within the scope of Phase 2, Clearing, Settlement, Collateral and Risk Management and Reporting Infrastructure will be renewed. In this framework, system and application infrastructure of our members may be effected due to changes in the business principle and technological infrastructure. In order to ensure that the technological transformation is realized swiftly and smoothly, it is important that all market participants are informed at every stage of the project. Therefore,

- On January 14, 2016 a BISTECH project meeting was held in order to inform members about system modifications. - On February 9, 2016 questionnaire regarding option exercise, on April 14, 2016 questionnaire regarding risk parameter file and on May 26, 2016 questionnaire regarding the progress of our participants were conducted.
- BISTECH Clearing Workstation User Manuel is updated in the scope of the amendments related with derivatives market functionalities and is available at member announcements section, as of August 17, 2016. Member trainings on BISTECH Clearing WS are planned on 21.08, 27.08, 28.08 and 03.09, as a one-day session. Additional trainings will be executed if needed.

- Document regarding the fundamental changes in the post trade with the BISTECH Futures and Options Market was published as of August 18, 2016.
