Subject: About the Change of Equity Repo Market Clearing and Settlement Start Time

Dear General Manager,

As known; the clearing and settlement process of the transactions executed in the Equity Repo Market, operating within the Borsa İstanbul A.Ş. Debt Securities Market, starts after 14:00 along with the Committed Transactions Market.

Within the context of adjusting the order entry and trading hours in the Equity Repo Market to 14:00 as stated in the announcement dated 14.08.2023 and numbered E-18454353-100.04.02-19073 published by the Borsa İstanbul A.Ş. Debt Securities Market, the system improvements related to changing the clearing and settlement starting time of the transactions in the Equity Repo Market to 15:00 have been completed.

In this regard, the revised "Debt Securities Market Clearing and Central Counterparty Service Principles Procedure" has been published on our Bank's website, and the comparison table regarding the changes made in the Procedure is included in the Appendix.

No changes were made in the clearing and settlement starting hours for other markets of the Debt Securities Market. Also the clearing and settlement ending hours of all markets remain unchanged, including the Equity Repo Market.

The implemented improvements and the updated Procedure will take effect on August 21, 2023.
