As it is known, currently physical equity securities free of payment transactions are conducted through

- Equity Securities Transactions/Free of Payment Transactions/Inter-Client Free of Payment Transfer of Physical Equity Securities/ Direct Physical Transaction Instruction submenu found on Takas Menu Web.

Based on demands from market participants, systemic developments enabling mentioned transfer transaction to be instructed via file transfer method are completed. In order to enable physical transaction through file transfer;

- Equity Securities Transactions/Free of Payment Transactions/Inter-Client Free of Payment Transfer of Physical Equity Securities/ **Physical Transaction Instruction with File Transfer Submenu** is added to Takas Menu Web.
