Subject: About the Minimum Default Interest and Base Value to be Applied in Equity, Debt Securities, BİAŞ Money Market, Swap, Derivatives and Over-the-Counter Derivatives Markets

in 2024

In accordance with the decision taken at our Bank's Board of Directors meeting dated 25 December 2023 and numbered 466; the minimum and maximum default interest / base value applied in case of delayed fulfillment of the obligations that will arise in the Equity Market, Debt Securities Market, BİAŞ Money Market, Swap Market, Derivatives Market and Over-the-Counter Derivatives in 2024 has been determined.

In the Debt Securities Market, no upper limit will be applied for obligations fulfilled after 17:30 on the value date. In addition, the minimum default base value application in the Equity Market will be abolished as of 2024.

The new limits provided in the table shall be effective as of January 1, 2024
