Dear General Manager,

Negotiated in the meeting of our Bank's Board of Directors dated 28.11.2025 and numbered 499, the changes in the fee schedule, which were submitted to the approval of the Capital Markets Board, within the framework of Article 25 of the Regulation on the Establishment and Working Principles of Central Clearing Institutions, titled "Product and Service Prices" were approved at the Board Meeting dated 29.01.2026 and numbered 5 (Decision No:214)..

Fees on Real-Time Gross Settlement (RTGS) instructions where Investment Funds are the cash parties, and fees on the creation/redemption of Exchange Traded Funds (ETF) shares will commence to accrue on a monthly basis, instead of real-time basis.

In this context, the fee changes in the attached tables are effective as of 2026, and the related changes are listed under the "Product and Service Prices" heading on our Bank's website.
