Securities Lending Market Commission	It is charged on the market value of the realized part of the orders in Takasbank Securities Lending Market	Market Value	Rates varying between 0.005% (0,5 basis points) and 0.48% (48 basis points) are applied according to the maturity of the transaction	23/08/2013 - 02/01/2023	-Takasbank commission is charged on the market value of realized part of the orders and collected both from the borrower and the lender. -For transactions with a maturity up to one week: 0.005% (0.5 basis points). -For transactions with a maturity of one week: 0.01% (1 basis points). -For transactions with a maturity of two weeks: 0.02% (2 basis points). -For transactions with a maturity of three weeks: 0.03% (3 basis points). -For transactions with a maturity of one month: 0.04% (4 basis points). -For transactions with a maturity of two months: 0.08% (8 basis points). -For transactions with a maturity of three months: 0.12% (12 basis points). -For transactions with a maturity of six months: 0.24% (24 basis points). -For transactions with a maturity of nine months: 0.36% (36 basis points). -For transactions with a maturity of one year: 0.48% (48 basis points). (SLM Takasbank commission, which is taken from contracts which consist on via special order, is 50% of current SLM commission tariff which changes with various maturities.) (SLM Takasbank commission rate, which will be collected from the lender member, is applied as 0% (zero percent) in contracts created with an automatic lending order.)
